What Personal Information Is Collected?

We collect the following Personal Information:

- (6) Automatically Collect Information
 - a. System Data: technical information such as your IP address, type of device being used to access the Website, browser and operating system type and version, and similar system data.
 - b. Log and Usage Data: data about your usage of the Website, such as the website that referred you (if applicable), pages viewed, date and time when you access information, and other data regarding your use of the Website.
 - c. Geographic Data: what country you are accessing the Website from based on your IP address

When and How Do We Collect Your Personal Information?

How Do We Use Your Personal Information?

Needle Play is based in the United States. Information about you will be transferred to, and processed in, the U.S. and countries other than the country in which you are resident. These countries may have data protection laws that are different to the laws of your country and, in some cases, may not be as protective. We have taken appropriate safeguards to require that your information will remain protected in accordance with this **Privacy Policy**.

We employ technical and organizational measures such as firewalls and encryption that are designed to appropriately protect your information that is under our control and that we process on your behalf from unauthorized access collection, use, disclosure, copying, modification or disposal, both during transmission and once we receive it. - For mergers, acquisitions, or sale of assets as necessary; and
 - a. To courts, law enforcement agencies, and governmental authorities (i) to comply with applicable law, including laws outside your country of residence; (ii) to comply with legal process; (iii) to respond to requests from public or government authorities, including public or government authorities outside your country of residence; (iv) to enforce the Terms; (v) to protect our operations; (vi) to protect our rights, privacy, safety or property, or that of you or others; or (vii) to allow us to pursue available remedies or limit the damages that we may sustain.

II. <u>DISCLOSURES</u>

California Residents.

California law allows California residents to ask companies with whom they have an established business relationship to provide certain information about the companies' sharing of personal information with third parties for direct marketing purposes. 1. CCPA Privacy Notice

GDPR Residents.
